

**Approved Permission for increase of 100 MBBS Seats for AY 2023-24  
(Increased from 150 to 250 MBBS Seats)  
(u/s 26(1)(a)(b) and 28 (1)(2) of the NMC Act, 2019)**

2. This permission for increase of 100 MBBS seats (from 150 to 250 MBBS Seats) and admission of students will be for such time the first batch of students admitted against the above course appears for the final examination in the subject. The college authorities may take up the matter for recognition of the qualification under section 35(2) of the IMC Act at the time of first batch admitted against the sanctioned intake 250 MBBS Seats **(150+100 Increased Seats for AY 2023-24). Thus the college will have 250 MBBS seats for the AY 2023-24.**

3. We are further directed to inform that you and your institution is fully responsible to fulfil and maintain norms including the infrastructure both physical and human resource, teaching faculty and clinical material etc. throughout the academic year, as stipulated in Regulation of National Medical Commission (NMC). It is mandatory to develop a biometric attendance, website on the medical college/institution and display all the information of the college, courses offered, faculty available and their experience of the last 5 years, students joined, and affiliating university. To display the hospital services, facilities available and the equipment in each speciality, also showing OP and IP census including births and deaths as per the Municipal/Govt. records.
